




# Overview of the Riverside County Office on Aging

- An Area Agency on Aging (AAA) is a public or private nonprofit agency designated by a state to address the needs and concerns of all older persons at the regional and local levels.
- AAA's are **responsible for** a geographic area, also known as a **planning and service area (PSA)**, and coordinate and offer services that help older adults remain in their homes, if that is their preference.
- The Riverside County Office on Aging (RCOoA) is a AAA responsible for Riverside County exclusively (PSA 21).




# Overview of Riverside County

- Riverside County is one of 58 counties in the state of California.
- It contains 28 incorporated cities, 65 unincorporated areas, 12 federally recognized American Indian reservations.
- According to the U.S. Census Bureau, Riverside County is the 10<sup>th</sup> largest county in the nation and the 4<sup>th</sup> most populated county in California.
  - In 2020, it had a population estimate of 2.4 million people.
  - Adults ages 65+ make up 14.8% of the county.




# An Aging Nation

- According to the U.S. Census Bureau, a
   major demographic shift is projected to
   occur by 2034:
  - Older adults are expected to outnumber children for the first time in history.
  - The number of older adults will only increase from that point forward:
    - By 2060, adults 65+ will make up 23.4% of the population, compared to 19.8% of children under.



# Riverside County Population Projections

- Between 2010-2020, Riverside County's population increased by 250,000 (10%).
- In 2034, the Riverside County population
  is expected to increase by 12.5%, totaling
  approximately 2.8 million.
- By 2060, the population is projected to increase to 3.1 million people.




# Riverside County's Aging Population

 Riverside County is amongst the top six counties in California with the largest older adult population projections. Within the 2010-2060 timeframe,
adults 65+ are expected to increase by
248.2%. Adults 85+ are expected to
increase by 711.5%.


# 2020 Riverside County Population by Ethnicity (2020 Census):



#### **LGBTQ Population**


- Proposition Propos
  - According to HARC, nearly 15% of people living in the Coachella Valley identify as LGBTQ, totaling nearly 50,000.
  - The percent of people who identify as LGBTQ in the Coachella Valley is double that of California as a whole (14.9% compared to 7.3%).


#### **American Indian Population**

- California is home to 109 federally recognized
   Indian Tribes and 100 reservations. Twelve
   reservations are in Riverside County.
- **52,000 people identify as American Indian** in Riverside County.



# Older Adult Workforce

- According to the U.S. Bureau of Labor and Statistics, in 2020, the U.S. workforce consisted of 8.6 million older adults ages 65 to 74 and 2 million older adults ages 75 and older.
- In Riverside County, approximately 27.6% of the total labor force are older adults. That is approximately 336,188 older adults currently working.
- Older adults are living longer and, therefore, choosing to work longer. Other motivations may include:
  - Fewer defined benefit retirement offerings.
  - Rising costs of living (i.e. housing, medical expenses).



# Veteran and Disabled Workforce

U.S. Veterans

In 2019, **18.8 million veterans** participated in the U.S. workforce.

Almost half of the veterans that were <u>ages</u> 45 to 54 in 2019 served in Gulf War I.

Gulf War I veterans will make up most of the older adult veteran population during the projected demographic shift in 2034.

People with a Disability

The unemployment rate for people with a disability is currently more than double that of people with no disability.

# Top 3 barriers to employment:

- -Disability
- -Lack of training and education
- -Lack of transportation

Compared to those without a disability, **people with a disability are more likely to take on employment**that involves production, transportation and material moving.

# United States' Poverty Measures

# The Federal Poverty Level

The Federal Poverty Level (FPL) is utilized to **determine income eligibility** for many public programs, **allocate funding** for other programs, and as an evaluation tool to determine program effectiveness.

- FPL takes a "one size fits all" approach to evaluating eligibility.
- According to FPL, the poverty guideline for a single adult nationally is \$12,880 per year in 2021.

### The Elder Index


The Elder Economic Security Standard Index (Elder Index) was developed by University of Massachusetts, Boston.

- It is geographically specific and provides data at the county level.
- Attempts to measure income inadequacy based on a basic standard of living for those who do not receive public welfare benefits.
- According to the Elder Index, the poverty guideline for a single adult living in **California** is **\$42,396** per year in 2021 (for renters).
  - For owners with a mortgage: \$50,124/year
  - For owners without a mortgage: \$31,668/year

# Older Adult Poverty in the U.S.

- Poverty rates are highest among the Black older adult population and lowest among non-Hispanic White older adults.
- When comparing poverty rates of men and women, women aged 80 and older had the highest poverty rate among all sexes and age groups in 2019.
- In 2019, poverty rates for people living alone doubled in comparison to older adults who lived with others.

# Older Adult Poverty in Riverside County

- According to the Elder Index, single older
   adults need approximately \$2,888/month in
   order to live independently in Riverside
   County.
- In 2015—the year of most updated information—
   24.2% of older adults lived in poverty in
   Riverside County.
- In Riverside County alone, **388,300 individuals** were in poverty between 2017 and 2019.

- Social Security
- Supplemental Security Income (SSI)
- Earnings
- Pensions

# **Other Financial Cost Factors to Consider:**

- Housing Costs.
- Medication Costs.
- Grandparents Raising Grandchildren.




# **Grandparents Raising Grandchildren**

- According to Generations United, 2.7 million children lived with grandparents in 2019; about 990,000 had their grandparents as sole guardian who met their basic needs.
- **Disparities exist** among grandfamilies according to their community, state, tribe, racial/ethnic group, and other family and personal characteristics.
- Although Black American individuals represent 14% of the U.S. population, they make up 25% of all children where a grandparent is the sole caregiver.

# Older Adult Homelessness


- Given California's high cost of living,
   older adults are often forced to
   choose between paying rent,
   buying groceries, or purchasing
   medications.
- Nearly half of those experiencing
  homelessness in the U.S. are 50 years
  and over. Sadly, many 50+
  homeless older adults do not
  make it to the age of 65.
- From 2017 to 2020, California saw a
   108% increase in older adult
   homelessness.



# Healthcare Workforce Crisis

- According to the California Health Care Foundation (CHCF), California had over 80,000 licensed behavioral health professionals in 2016.
  - They were unevenly spread across the state and did not reflect the racial/ethnic diversity of the state's population.
  - Approximately 647,897 people in Riverside
     County live in an area that has a shortage of primary care providers.
- Within the next 10 years, a large proportion of healthcare workers will reach retirement age, meaning there will be less physicians serving the projected older adult population increase.






# Caregiver Workforce Crisis

- The lack of competitive wages deters people from joining the workforce.
  - In 2018, the nation's estimated 4.6 million home care aides earned a median of \$12 an hour and \$17,200 annually.
- When comparing direct care workers' median wage with those of other occupations with similar entry-level requirements, direct care workers made \$3.86 less.
- According to the Bureau of Labor Statistics, the nation experienced estimated job losses of 342,000 in the direct care workforce.


# **Direct Worker Workforce Estimates and Projections**



The **pandemic has fueled demand** for caregivers in people's homes; between March 2020 and January 2021, **demand grew by 125 percent.**

Number and Ages of People 65 or Older with Alzheimer's Dementia, 2021\*



- According to Alzheimer's Association, an estimated 6.2 million older adults lived with Alzheimer's dementia in the U.S. in 2021. By 2050, it is projected to reach 12.7 million.
- 1 in 6 Californians over the age of 65 will
   develop Alzheimer's, and 1 in 5 will
   develop dementia.
- Californians who identify as LGBTQ living
   with dementia will more than double in
   2040, growing to 74,522.
- By 2040, Riverside county will see a 141%
   increase in people living with Alzheimer's.

# Health and Wellness Profile: Fall Prevention



\*Percent of older adults who reported a fall

- According to the Center for Disease Control (CDC), falls are the leading cause of injury-related death among persons aged 65 and above.
  - In 2019, there were approximately 34,000 deaths among older adults who fell.
  - Falls amongst older adults are
     projected to increase from 52 million
     people in 2018 to 73 million people in

     2030.
- 3 million older adults are treated in emergency departments annually, costing \$50 billion in medical costs.

# COVID-19 Pandemic Update

### **Vaccination Status**

- According to the CDC, 1.6 million (65.7%) of Riverside County's population has received at least one dose against COVID-19.
  - 1.4 million (52.6%) have been fully vaccinated.
  - Older adults make up 95% of those who have received at least one dose and 82.7% who are fully vaccinated.
- As of January 2022, approximately 60.5% of fully-vaccinated older adults in Riverside County have received booster shots.





## **RCOoA COVID-19 Response**

Between October 2020 and March 2021, RCOoA received
 160,790 incoming calls, contacted 55,419 clients, and made 20,282 vaccine registration appointments for older adults and individuals with disabilities across Riverside County.

### IMPORTANT MEDICARE ENROLLMENT PERIODS

# March 31 is a Double Deadline for People Eligible for Medicare

Advocates working with clients eligible for or enrolled in Medicare should be aware of two important opportunities with a March 31 deadline:

### Medicare General Enrollment Period (GEP): January 1 – March 31

Individuals who wish to enroll in Medicare Part A and/or Part B and do not have an Initial Enrollment Period or a Special Enrollment Period based on employer coverage, can only enroll during the GEP. GEP enrollment is through the Social Security Administration (SSA) with coverage starting July 1.

This deadline is particularly important for individuals in ALABAMA, ARIZONA, CALIFORNIA, COLORADO, ILLINOIS, KANSAS, KENTUCKY, MISSOURI, NEBRASKA, NEW JERSEY, NEW MEXICO, SOUTH CAROLINA, UTAH, AND VIRGINIA who do not have premium-free Part A and may be eligible for the Qualified Medicare Beneficiary (QMB) program. In these states (called "group payer" states), individuals without premium-free Part A coverage must apply at SSA for "conditional" Part A during the GEP before they can apply with their state for the QMB program. If they miss the March 31 deadline, they must wait until the next year before the can apply for QMB coverage.

### Medicare Advantage Open Enrollment Period (MA-OEP): January 1 – March 31

During the MA-OEP, individuals enrolled in Medicare Advantage (MA) plans can drop their MA coverage and choose original Medicare with a Prescription Drug Plan (PDP), or change from one MA plan to another, with or without prescription drug coverage. Individuals in Original Medicare may not use the MA-OEP to change their standalone Part D Plan choice or join an MA plan. For enrollees without the Low-Income Subsidy (LIS), this is the last opportunity in the year to change coverage during the year unless they qualify for a Special Enrollment Period (SEP), for example, if they move out of the plan service area. Medicare enrollees with the Low-Income Subsidy ("Extra Help") have a SEP that provides one opportunity each quarter to make any change in plan coverage.

Medicare plan marketing, especially television marketing, has been intense during both the fall enrollment period and the current MA-OEP. Options for MA plans to offer supplemental benefits also have made choosing a plan more complex and confusing. The MA-OEP is a good opportunity for advocates to urge Medicare enrollees to seek unbiased assistance from HICAP/SHIP counselors to ensure that they are making appropriate choices, have access to their preferred providers, and are getting prescription drug coverage that meets their needs.

# A RESOLUTION OF THE RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING RE-AUTHORIZING REMOTE TELECONFERENCE MEETINGS OF THE LEGISLATIVE BODIES OF THE RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING FOR THE PERIOD FEBRUARY 14, 2022, THROUGH MARCH 16, 2022, PURSUANT TO THE RALPH M. BROWN ACT.

**WHEREAS**, all meetings of RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING and its legislative bodies are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 – 54963), so that any member of the public may attend, participate, and view the legislative bodies conduct their business; and

**WHEREAS**, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions and requirements; and

**WHEREAS**, a required condition of Government Code section 54953(e) is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558(b); and

WHEREAS, a further required condition of Government Code section 54953(e) is that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body holds a meeting to determine or has determined by a majority vote that meeting in person would present imminent risks to the health and safety of attendees; and

**WHEREAS**, on March 4, 2020, Governor Newsom issued a Proclamation of a State of Emergency declaring a state of emergency exists in California due to the threat of COVID-19, pursuant to the California

Emergency Services Act (Government Code section 8625); and,

**WHEREAS**, on June 11, 2021, Governor Newsom issued Executive Order N-07-21, which formally rescinded the Stay-at-Home Order (Executive Order N-33-20), as well as the framework for a gradual, risk-based reopening of the economy (Executive Order N-60-20, issued on May 4, 2020) but did not rescind the proclaimed state of emergency; and,

**WHEREAS**, on June 11, 2021, Governor Newsom also issued Executive Order N-08-21, which set expiration dates for certain paragraphs of the State of Emergency Proclamation dated March 4, 2020, and other Executive Orders but did not rescind the proclaimed state of emergency; and,

**WHEREAS**, as of the date of this Resolution, neither the Governor nor the state Legislature have exercised their respective powers pursuant to Government Code section 8629 to lift the state of emergency either by proclamation or by concurrent resolution the state Legislature; and,

WHEREAS, the California Department of Industrial Relations has issued regulations related to COVID-19 Prevention for employees and places of employment. Title 8 of the California Code of Regulations, Section 3205(5)(D) specifically recommends physical (social) distancing as one of the measures to decrease the spread of COVID-19 based on the fact that particles containing the virus can travel more than six feet, especially indoors; and,

WHEREAS, on January 12, 2022, the RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING previously adopted Resolution No. 2022-001, finding that the requisite conditions existed for the RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING and its legislative bodies to conduct remote teleconference meetings without compliance with Government Code section 54953 (b)(3), as authorized by Section 54953(e); and,

WHEREAS, as a condition of extending the use of the teleconferencing provisions for another 30 days beyond the Resolution No. 2022-001 adopted on January 12, 2022, pursuant to Government Code Section 54953(e), the RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING must reconsider the circumstances of the state of emergency that exists and find that either the state of emergency continues to directly impact the ability of the members to meet safely in person or state or local officials continue to impose or recommend measures to promote social distancing; and,

WHEREAS, the RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING has reconsidered

the circumstances of the state of emergency and finds that state or local officials continue to impose or recommend measures to promote social distancing, based on the California Department of Industrial Relations regulations related to COVID-19 Prevention, specifically, Title 8 of the California Code of Regulations, Section 3205(5)(D), continuing to remain in effect; and,

WHEREAS, as a consequence, the RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING does hereby find that it and its legislative bodies may continue to conduct their meetings by teleconferencing without compliance with Government Code section 54953 (b)(3), pursuant to Section 54953(e), and that such legislative bodies shall comply with the requirements to provide the public with access to the meetings as prescribed by Government Code section 54953(e)(2).

**NOW, THEREFORE, BE IT RESOLVED, FOUND AND ORDERED** by RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING, State of California, in regular session assembled on February 9, 2022, does hereby resolve as follows:

Section 1. Recitals. All of the above recitals are true and correct and are incorporated into this Resolution by this reference.

Section 2. Reconsideration of the State of Emergency. The RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING has reconsidered the circumstances of the state of emergency that continues to exist and was proclaimed by the Governor through a State of Emergency Proclamation on March 4, 2020.

Section 3. State or Local Officials Continue to Impose or Recommend Measures to Promote Social Distancing. The RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING hereby proclaims that state officials continue to impose or recommend measures to promote social (physical) distancing based on the continuance of California Department of Industrial Relations regulations related to COVID-19 Prevention through Title 8 of the California Code of Regulations, Section 3205(5)(D).

Section 4. Remote Teleconference Meetings. The RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING and any of its legislative bodies are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.

This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of (i) MARCH 12, 2022 or (ii) such time the RIVERSIDE COUNTY ADVISORY COUNCIL ON AGING adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which its legislative bodies may continue to teleconference without compliance with Section 54953(b)(3).

### **CODE OF ETHICS**

Recognizing that the needs of the over 60 age groups are in the interests of all people, the California Legislature in 1980 created the California Senior Legislature to propose legislation to meet the needs and concerns of Older Californians.

### As a member of the CSL I:

- 1. Shall be non-partisan.
- 2. Shall represent the best interests of state-wide California elderly.
- 3. Shall express the major concerns of the elderly.
- 4. Shall speak for the CSL on CSL-approved issues only. Otherwise, shall identify myself as a CSL member expressing own personal views.
- 5. Shall use only CSL authorized cards and stationery.
- 6. Shall identify myself as "Senior Senator" or "Senior Assemblymember" or "Senior Assemblywoman" or "Senior Assemblyman." If given "Emeritus" status one should identify themselves as either "Senior Senator Emeritus" or "Senior Assemblymember/woman/man Emeritus".
- 7. Shall accept the responsibility for submitting at least one proposal every two years.
- 8. Shall accept the responsibility for attending and participating in all meetings of the Annual Session, except when an extreme emergency arises.
- 9. Shall develop working relationships in my PSA (Planning and Service Area) with the Area Agency on Aging, the Advisory Council or Commission on Aging and other senior groups and caucuses; and shall routinely attend their meetings and report on CSL activities.
- 10. Shall develop working relationships with my State and National Legislators and their staffs, particularly with my Legislators' District's staffs.
- 11. Shall develop and maintain a local legislative advocacy program, keeping up a two-way communication with my constituents.
- 12. Shall activate letter and phone campaigns to support CSL priority proposals.
- 13. Shall respond to calls (Alerts) from the Joint Rules Committee (JRC) to write letters, make phone calls, and visit my State Legislators and their District offices on behalf of CSL priority issues.
- 14. Shall develop and carry out local public relations and publicity for goals established by the CSL.
- 15. Shall study the Annual Schedule of Suggested Activities and follow this schedule whenever its items are applicable to my local situation.

- 16. Shall maintain a professional working relationship with all members of CSL as well as with the Area Agency on Aging and the Advisory Council or Commission on Aging.
- 17. Shall endeavor to raise funds throughout the year in order to meet the funding needs of CSL for travel and reimbursement of expenses of the Annual General Session and for meetings..
- 18. Shall promote CSL fund-raising activities on a local and statewide level.

As a member of CSL I acknowledge that:

- 19. Failure to submit at least one original proposal in any one of two consecutive years constitutes failure to live up to this commitment.
- 20. **Failure to live up** to the STATEMENT OF COMMITTMENT and the CODE OF ETHICS is grounds for review, reprimand and possible removal from office by JRC Executive Committee action.
- 21. All decisions regarding my candidacy, election and/or recall are the responsibility of the CSL JRC and are final and binding.
- 22. There is no salary connected with this position and that lodging, meals and transportation costs will be furnished for the Annual Session, provided funds are available.
- 23. Lodging, meals and transportation costs may be furnished for Legislator visits ("Walk the Halls") during the course of the year provided funds are available.
- 24. Expenses for postage, copying, printing and telephone usage during the year are my responsibility. Transportation costs not referenced above are my responsibility as well.
